## Re: CONSULTATION ON MOVING INLAND WATERWAYS INTO A NEW CHARITY IN ENGLAND AND WALES

- 1. We are writing to invite views on the proposed New Waterways Charity which will take over responsibility for the inland waterways that are currently managed on behalf of the Secretary of State for Environment, Food and Rural Affairs.
- 2. Waterways deliver considerable and extensive benefits ranging from stimulating regeneration in our inner cities to the public enjoyment of the rich natural environment.
- 3. Our intention with the creation of a new charity is to enable the waterways' potential to be realised and their future safeguarded. The Government's proposals will further enhance the public benefits of inland waterways by widening the involvement of stakeholders. This reflects the Government's Big Society agenda of which the civil society is an important part. It will enable people to have a real say in how their local waterways are run.
- 4. This consultation document has been developed under the aegis of a Project Board which includes representatives from Defra, Her Majesty's Treasury, the Office of the Civil Society, British Waterways and the Environment Agency. We have also taken account of the wide variety of views expressed by stakeholders at focus groups, workshops and other meetings during 2010.
