Thanks for this. Obviously disappointed that LVRP not able to contribute to costs, but have managed to find a small sum for Madge to pick up some of the work.

Our internal strategy working group met again yesterday and I'm attaching a brief note of key points arising. As you'll see, we concentrated effort on the process for identifying pockets of offside moorings where we're unclear on land ownership and management responsibility. Our aim is to establish contact with land owners, and we hope very much that we may draw on your databases and contacts with riparian boroughs to assist in this.

I noted three actions from the meeting - I think that everything else was in the paper dated 17th Nov.
